#### 1.0 Opening of the Meeting

On opening the meeting the Director IQAC welcome the members to the meeting and invited the Vice Chancellor for his opening remark

#### 2.0 OPENING REMARKS BY THE VICE-CHANCELLOR, CHAIRMAN IQAC:

Furthermore, we'll delve into refining our curriculum to address cross-cutting issues and fostering effective mentor-mentee relationships within our programs. Additionally, we'll explore innovations in our examination and evaluation systems, ensuring they remain robust and reflective of our commitment to academic excellence. I encourage active participation and constructive dialogue as we collectively steer our institution towards greater heights of academic achievement and societal impact.

### 4.0 PRESENTATION BY DIRECTOR IQAC ON IMPLEMENTATION OF PREVIOUS IQAC MEETING

**RECOMMENDATIONS:** The Director IQAC presented the action taken on the recommendation of the previous meeting as given below

- 1. The University's long-term and short-term plans have been finalized
- 2. The proposed career development plans of the departments have been finalized and recommended for implementation.
- 3. Approved activities by the committee:
  - i. Organzing a Kishan Mela by the Faculty of Agriculture Science and Technology.
  - ii. Hosting an International Seminar and Mining Expo by the Faculty of Engineering and

Technology.

- iii. Arranging an International seminar on the latest developments by the Faculty of Basic Science.
- 4. The proposed Faculty Development Program on curriculum design, question paper design for evaluation, and enhancing student employability received approval. Dr. Mahendra Tiwari, in charge, was tasked with identifying resource persons and scheduling the program.

## 5. REPORTS ON INDUCTION PROGRAM ORGANIZED BY RESPECTIVE IN-CHARGES AND SUBMISSION OF THE REPORT BOTH HARD AND SOFT COPY)

Each of AKS University's 29 departments outlined their induction programs during the session, led by respective Heads of Departments (HoDs). These sessions aimed to acquaint students with university activities, academic frameworks, and evaluation systems. The Director of IQAC urged departments to submit reports detailing their induction efforts.

### 6. IMPLEMENTATION OF SUSTAINABLE DEVELOPMENT GOALS AND IKS in the University

Dr. Mahendra Tiwari and Dr RL Shikharwar presented Sustainable Development Goals (SDGs) and Indian Knowledge Systems (IKS) for implementation at AKS University. - 8.0 FINALIZATION OF FACULTY DEVELOPMENT PROGRAMS (FDPS) FOR THE FACULTY OF LAW, FACULTY OF AGRICULTURE SCIENCE AND TECHNOLOGY, AND FACULTY OF PHARMACEUTICAL SCIENCE AND TECHNOLOGY, SPECIFICALLY FOCUSING ON THE DESIGN OF CURRICULA: During the meeting, it was proposed to organize a faculty development program aimed at curriculum development for the Faculty of Law, Faculty of Agricultural Science and Technology, and Faculty of Pharmaceutical Science and Technology at AKS University. This initiative aims to promptly assist faculty members in curriculum design for these specific disciplines. By providing targeted training, the university intends to enhance the quality and relevance of the curricula offered in these faculties, thereby better preparing students for their respective fields.
- 9.0 THE CROSSCUTTING ISSUES WITHIN CURRICULA AND HOW IT CAN INTEGRATE THEM IN CURRICULA: The Vice-Chancellor addressed the integration of crosscutting issues within curricula, emphasizing the importance of incorporating them seamlessly. This directive underscores the need for curricula to encompass multidisciplinary perspectives and address contemporary challenges comprehensively. By integrating crosscutting issues such as sustainability, diversity, and ethics into the curricula, AKS University aims to equip students with a holistic understanding of their fields and
