Ensuring Continuity of Teaching and Learning During COVID-19 Lockdown the vice chancellor advice some key steps as noted below

- i. Remote Teaching Strategies: Recognize that the traditional in-person approach may not suffice. Many students now attend classes from different time zones or while juggling work and family responsibilities. To address this, maintain regular communication with students through brief video messages before each session. Encourage them to turn on their cameras for a more personal connection.
- **ii. Flexible Learning Environments**: Acknowledge that boundaries between personal and professional spaces have blurred. Be empathetic and understanding, fostering trustful relationships with students. Consider their unique circumstances and create an inclusive virtual learning environment.
